**Reclamation of 500-NXX assignments**

**500-NXX:**

NANPA has recently conducted an audit of the 500-NXX resource. As a result of information obtained during this audit, it has come to our attention that numerous assignee companies are no longer in business. Letters were sent to the address of record for these assignees via Fed Ex or USPS Priority Mail, requiring that they produce specific information in response to the audit of their assignments.

Seven (7) of the letters sent to these assignees were returned to NANPA as undeliverable by Fed Ex or by the USPS. Contact information in our records was determined to be outdated and/or invalid (i.e., mailing addresses, email addresses and telephone numbers). Accordingly, NANPA has concluded that these companies are no longer in business, but the 500-NXX blocks assigned to the companies were not returned to NANPA by the assignee. According to terms set forth in Section 7.2, "Administrator Responsibility", of the PCS 5YY NXX Code Assignment Guidelines, NANPA is to notify INC when these circumstances occur, and also to advise INC that these 500-NXX codes will be reclaimed unless INC advises otherwise within 30 days. These 500-NXX assignments are currently reflected in NANPA's 500-NXX database with no contact information, and are included on the attached listing for INC's determination as to reclamation.
