Abstract

This IL provides industry notification of the impending split of the 206 NPA.

Letter Information (includes safety liability disclaimer (if applicable), ordering information, originator's signature information)

We have been advised by USWEST that substantial telephone number growth in the Seattle/Tacoma area of Washington State necessitates splitting the existing 206 NPA (area code) and the simultaneous introduction of a new 360 NPA.

The Seattle/Tacoma/Everett metropolitan area will retain the 206 area code, and the remainder of the current 206 NPA will be transferred to the new 360 area code.

The split of the 206 NPA is scheduled for 12:01 AM Pacific Standard Time, Sunday, January 15, 1995. The permissive dialing period will begin at 12:01 AM Pacific Standard Time, Sunday, January 15, 1995 and end at 12:01 AM Pacific Daylight Saving Time, Sunday, July 9, 1995. During the permissive dialing period either 206 or 360 will be acceptable in a dialed number terminating in the new 360 NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept. Changes in the local exchange routing information, based on data provided by USWEST, will be incorporated into the LERG and the NPA NXX Activity Guide (NNAG) and will be available June 1, 1994.

The dates that switching systems in the new 360 NPA will begin transmitting "360" in the calling number Automatic Number Identification (ANI) will be coordinated by USWEST with the interexchange carriers.

Details regarding testing of the new NPA are not available at this time.

The attached map illustrates the 206 and 360 configuration after the split. A listing of of the communities to be served by each area code is also included.

The dialing plan for the new 360 and 206 NPAs will be the same:

- All home NPA (HNPA) "local" calls will be dialed on a 7 digit basis with no prefix; i.e., NXX + XXXX (7digits).

- All HNPA direct dialed "toll" calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + HNPA + NXX + XXXX (1 + 10 digits).
- All foreign NPA (FNPA) direct dialed "toll" calls will be dialed with a prefix "1" and 10 digits; i.e., 1 + FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted calls including credit card, collect, and third party calls will be dialed with a "0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX (0 + 10 digits).

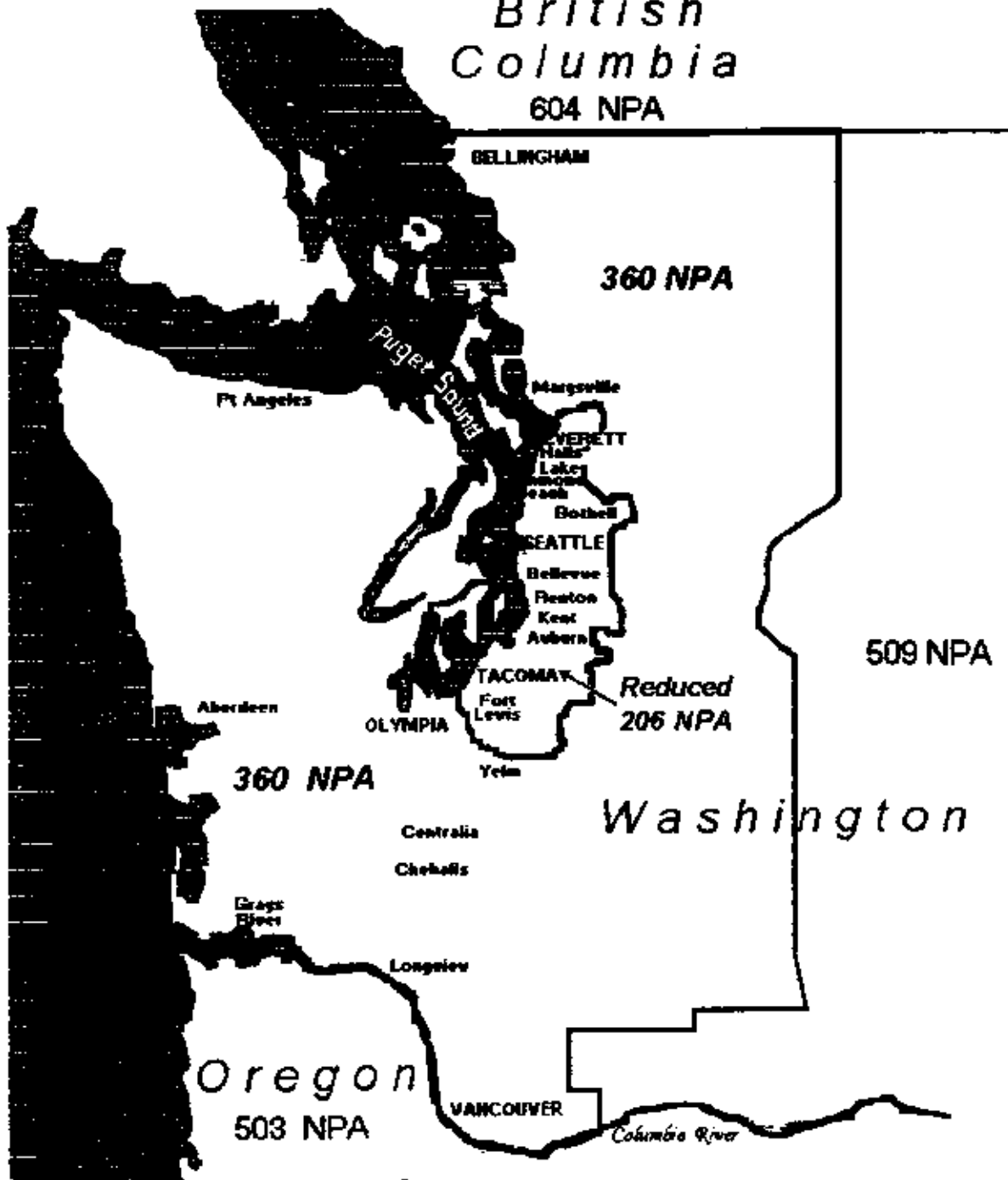
