Three all-services overlays are to be implemented in Michigan as described in this letter.

NPA 947 will overlay NPA 248. NPA 947 will be introduced on May 5, 2001. In preparation for the overlay, permissive 10-digit dialing of all local calls will begin on February 3, 2001.

NPA 679 will overlay NPA 313. NPA 679 will be introduced on February 3, 2001. In preparation for the overlay, permissive 10-digit dialing of all local calls will begin on November 4, 2000.

NPA 278 will overlay NPA 734. NPA 278 will be introduced on November 4, 2000. In preparation for the overlay, permissive 10-digit dialing of all local calls will begin on July 8, 2000.

Maps of the new NPA configurations are attached.

The dialing plan described below will be permissive in each of the NPAs as of the dates given above. The dialing plan will become mandatory on the effective date of each overlay NPA.

- All local calls within the 248/947 NPAs, the 313/679 NPAs, and the 734/278 NPAs will be dialed as 10 digits (NPA + NXX + XXXX), or, as the prefix “1” followed by 10 digits (1 + NPA + NXX + XXXX).
- All toll calls originating in any of the above NPAs will be dialed with a prefix “1” and 10 digits (1 + NPA + NXX + XXXX).
- All operator assisted calls, including credit card, collect, and third party calls, will be dialed with a “0” prefix and 10 digits (0 + NPA + NXX + XXXX).

International and domestic carriers should ensure that the new overlay NPAs have been activated throughout their networks prior to their introduction. Test calls to verify routing to the new NPAs can be made by dialing 947-485-1234, 679-692-1234, or 278-323-1234. The effective dates for these test numbers are February 3, 2001, November 4, 2000, and July 8, 2000, respectively. Calls successfully completed to the test numbers will receive a recorded announcement.

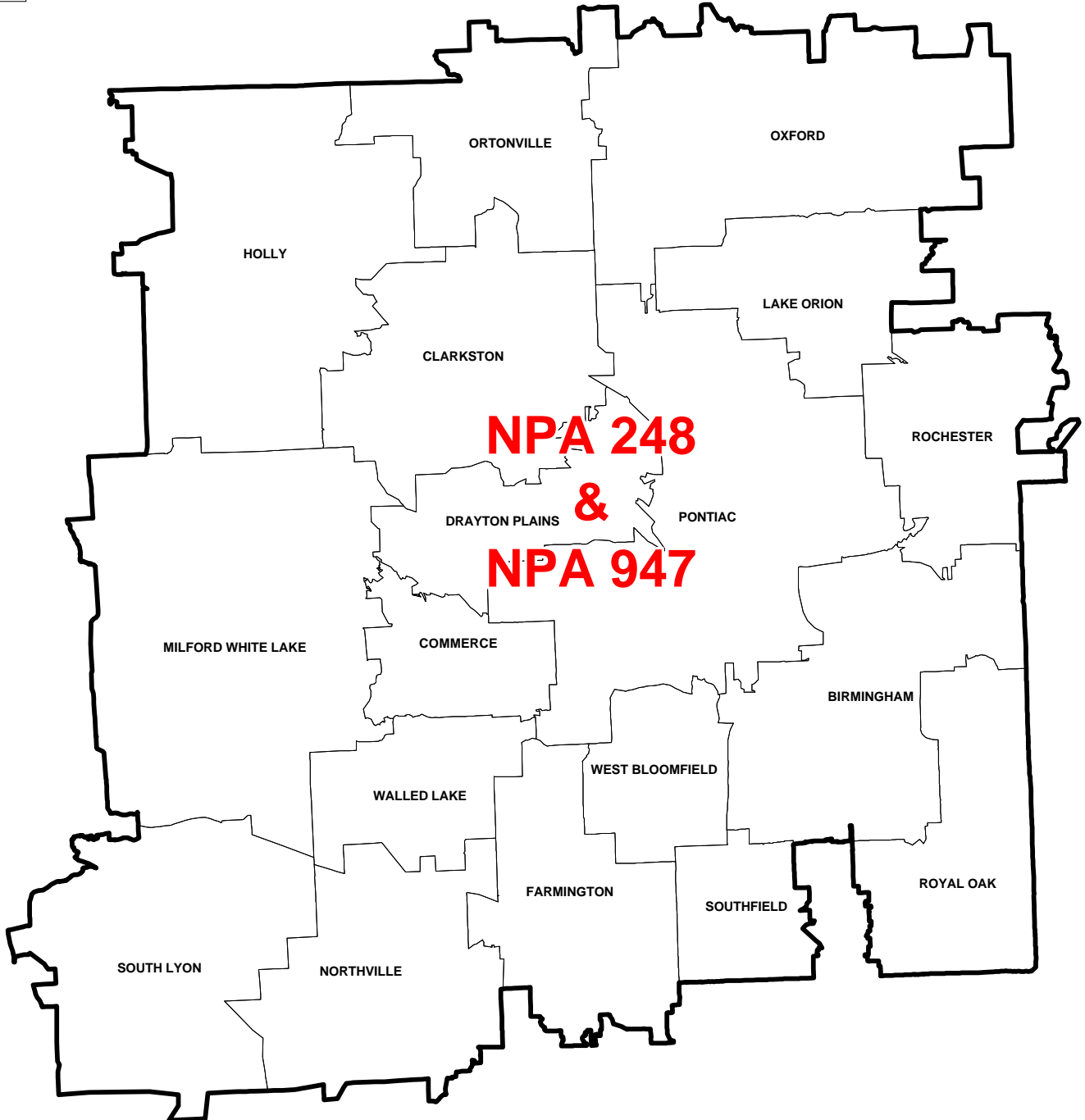
# NPA 248/947 Rate Center Map

# NPA 248/947 County/City Map

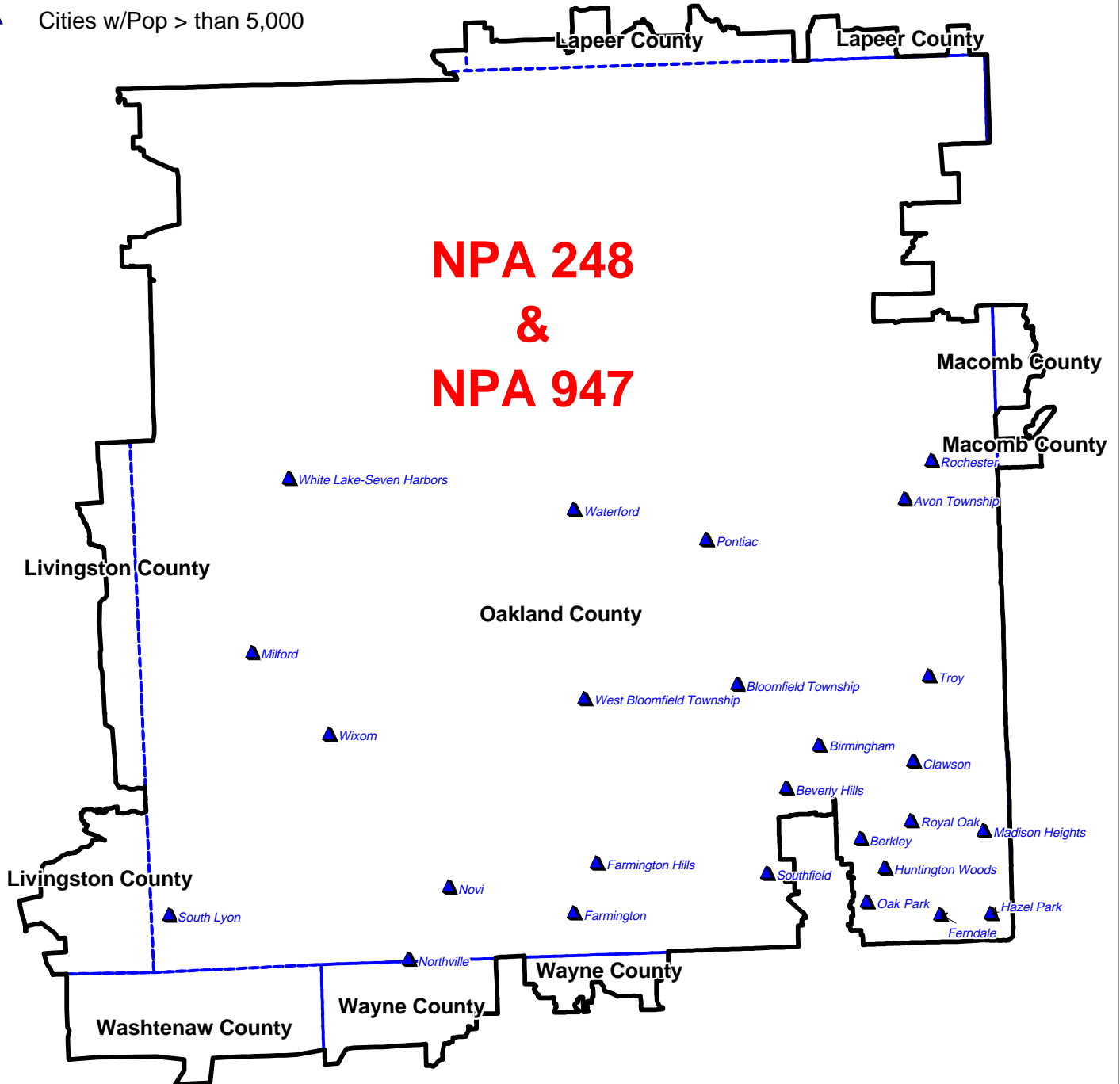



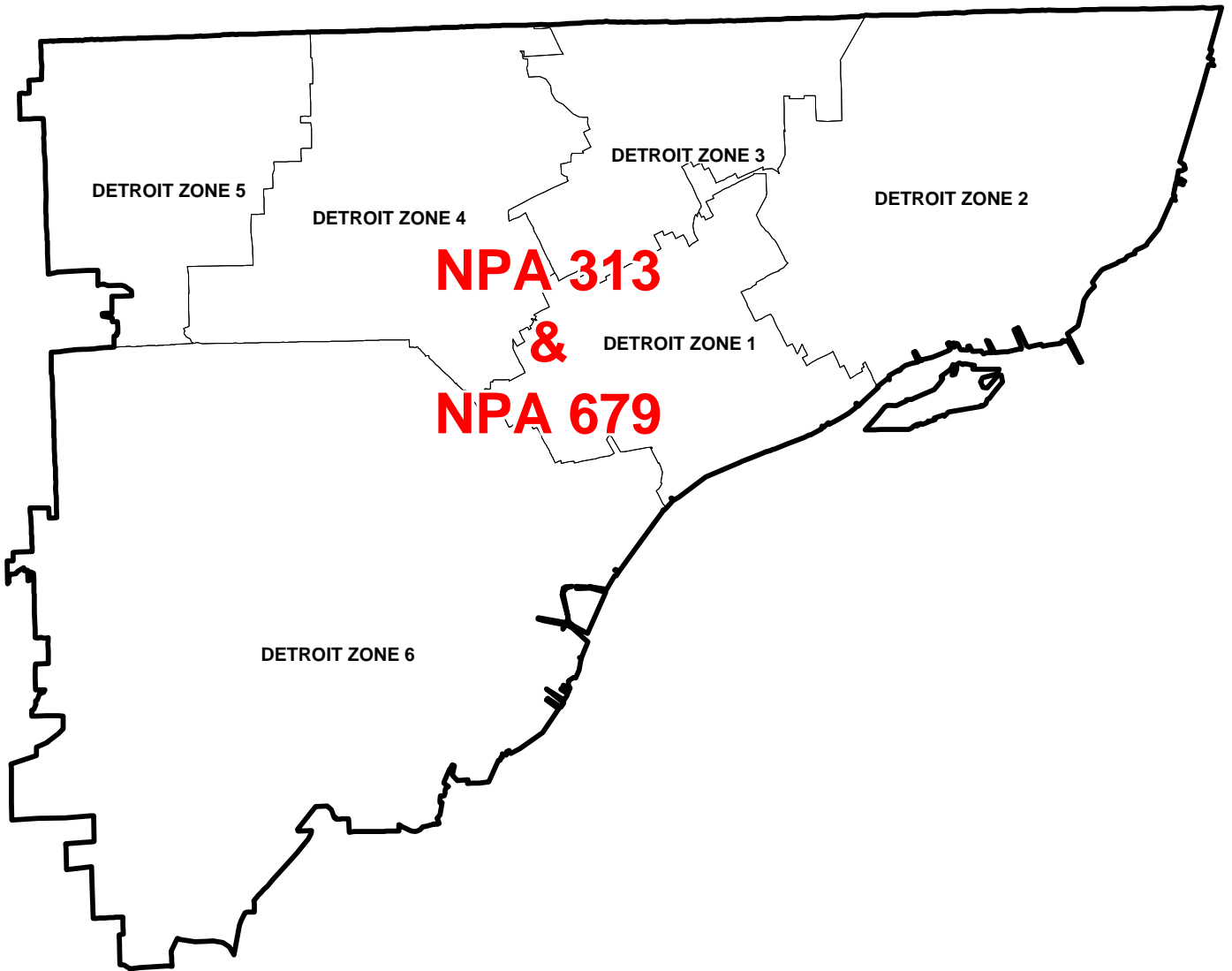

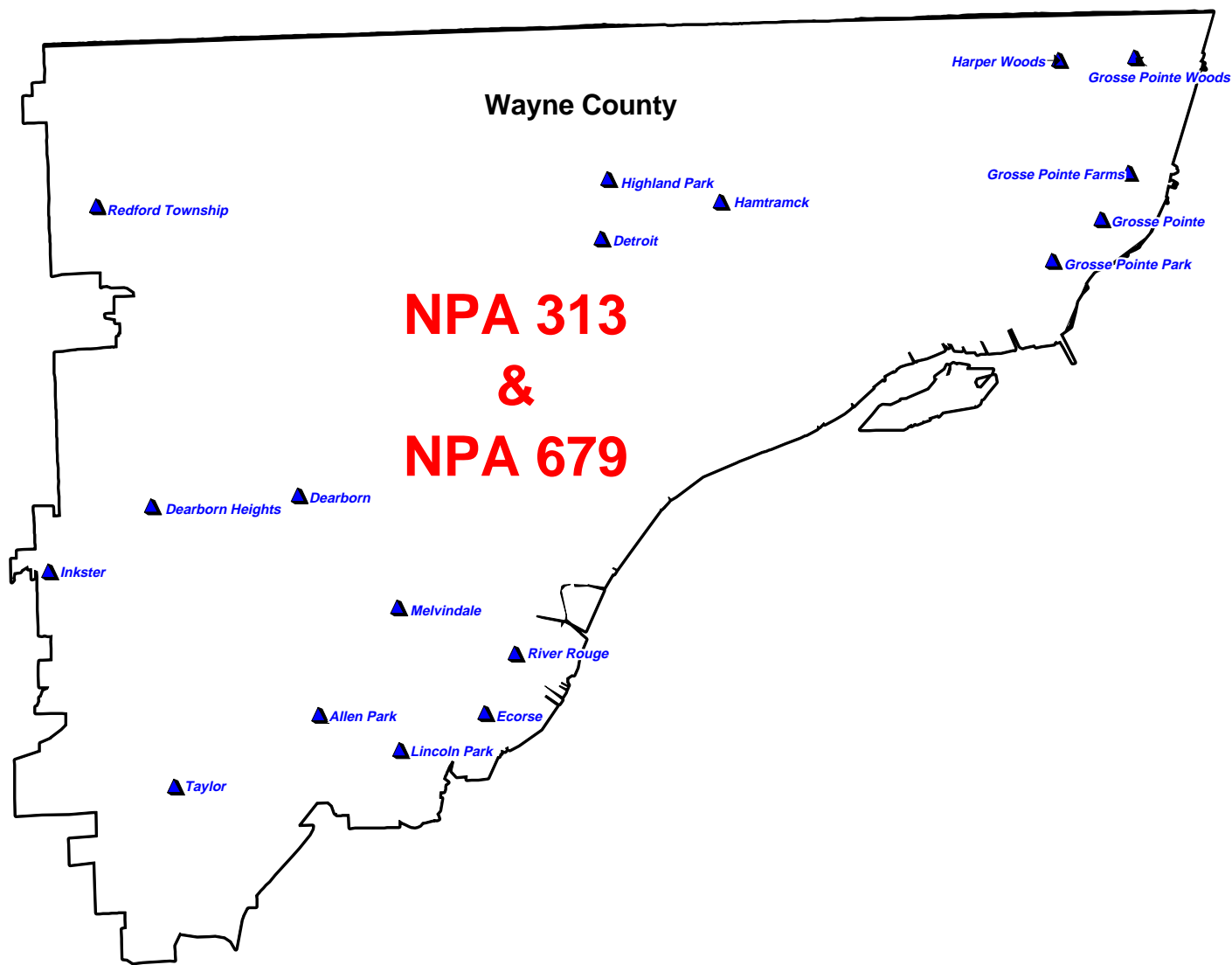

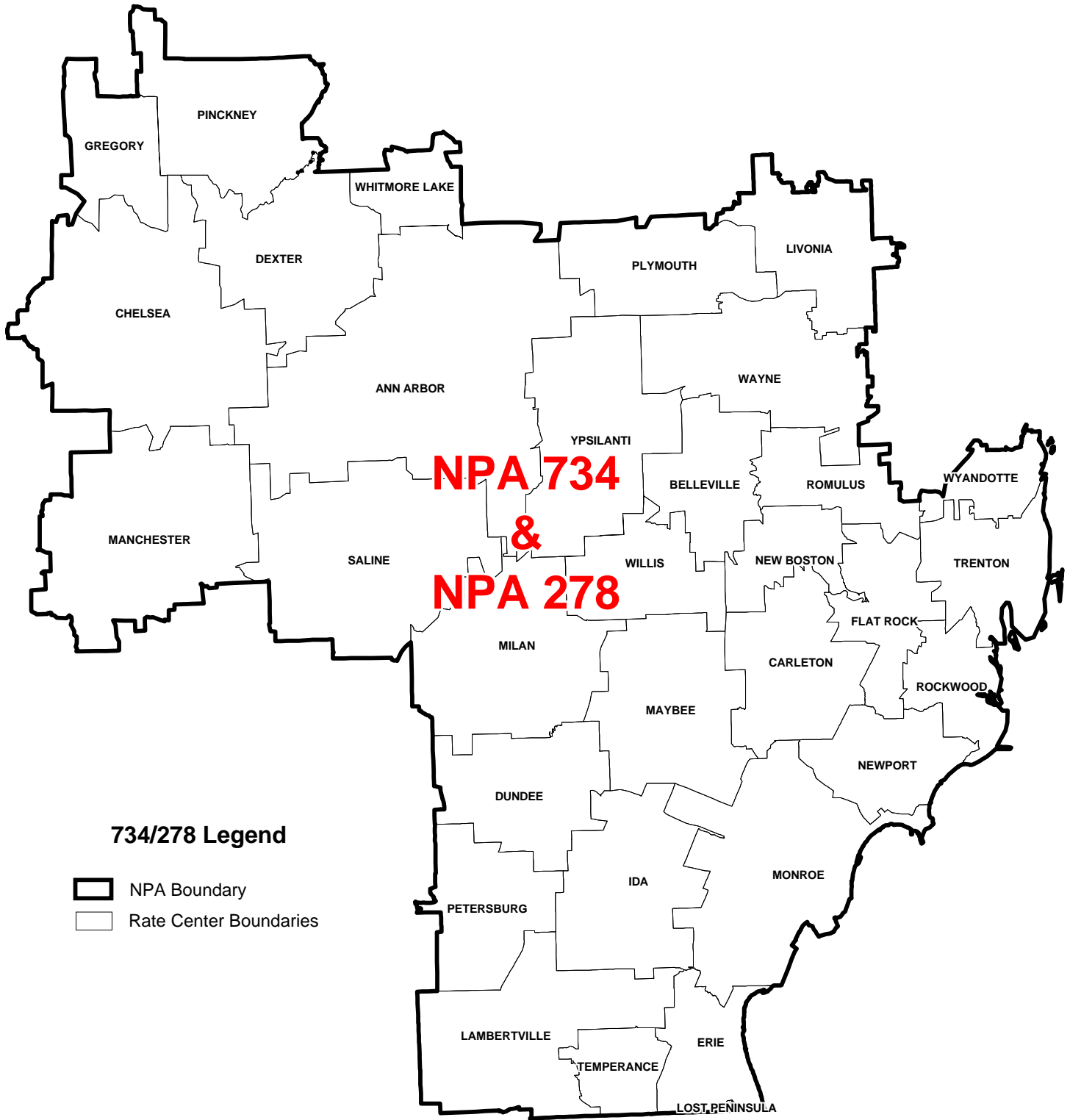
