Subject: Changes to the 415 and 714 NPA (California) Relief Plans

---

We have been asked by the California Code Administrator (CCA) to announce changes that have been made to the relief plans for the 415/650 and 714/949 NPA splits in California as previously described in Bellcore Planning Letters PL-NANP-022 and PL-NANP-044, respectively. The CCA does not intend to assign duplicate central office codes (NXXs) in the old and new NPAs during the permissive dialing period as originally planned. Therefore, calls to NXXs assigned during the permissive period may be dialed correctly with either the old or the new NPA (see attachments which show text in the third paragraph of the PL's that should be deleted). In all other respects, the relief plans for the 415 and 714 NPAs are unchanged.

Subject: NANP-Split of 415 (California) Numbering Plan Area (NPA)

---

We have been advised by Pacific Bell, the California Code Administrator (CCA), that substantial number growth in the San Francisco area of California necessitates providing area code relief for the 415 NPA. The relief plan, approved by the California Public Utilities Commission, calls for a geographic split of the 415 NPA and the simultaneous introduction of a new 650 NPA. The following is a description of this relief plan.

The existing 415 NPA will be split just south of San Francisco. Communities and areas north of the boundary will retain the 415 NPA and include San Francisco, Marin County, most of Brisbane and part of Daly City. The remaining communities in the current 415 NPA, which include Millbrae, San Bruno, South San Francisco, part of Daly City, part of Brisbane, and the San Francisco airport, will transfer to the new 650 NPA.

The split of the 415 NPA, and the beginning of a permissive dialing period, will take place at 2:00 AM Pacific Daylight Time (PDT) on Saturday, August 2, 1997. The permissive dialing period will end at 2:00 AM PST on Saturday, January 31, 1998. During the permissive dialing period, either the 415 or 650 NPA code will be acceptable in a dialed number terminating in the new 650 NPA. ~~for all central office codes (NXXs) in service prior to the beginning of the permissive period. Please note: For NXXs that are opened in the 415 and 650 NPAs after the start of the permissive dialing period, the calling party must dial the appropriate NPA. Calls to these NXXs will be routed to intercept if the incorrect NPA is dialed.~~ After the permissive period, all calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

The attached map illustrates the 415 and 650 NPA configuration after the split. Also attached are listings of the assigned NXXs for the 415 and 650 NPAs as of October 1, 1996. The NXX information provided includes NPA, switch identification, rate center identification and rate center name, and is sorted two ways: by NXX and by rate center name. Updated NXX information may also be found either in the LERG or the NPA NXX Activity Guide (NNAG). Current information in the LERG and NNAG is available by license contract from Bellcore's Traffic Routing Administration (TRA) group, which can be contacted by dialing the TRA Hotline at 908-699-6700.

All international and domestic carriers are asked to ensure that the new 650 NPA has been activated throughout their networks prior to August 2, 1997. Test calls to verify routing to the new NPA can be made by dialing 650-777-0650, effective May 17, 1997. It is not expected the test number can be reached from outside the 415 NPA until shortly before the beginning of permissive dialing. Calls successfully completed to the test number will receive a recorded announcement. The test number will be disconnected May 1998.

Subject: NANP-Split of 714 (California) Numbering Plan Area (NPA)

We have been advised by the California Code Administrator (CCA) that substantial number growth in the Orange County area of southern California necessitates providing area code relief for the 714 NPA. The relief plan, approved by the California Public Utilities Commission, calls for a geographic split of the 714 NPA and the simultaneous introduction of a new 949 NPA. The following is a description of this relief plan.

The northern portion of the current 714 NPA including Huntington Beach, Santa Ana and Tustin will retain the 714 NPA. The remainder of the 714 NPA, which includes Costa Mesa and Irvine in the south, will transfer to the new 949 NPA. A listing of cities to be served in each NPA after the split is attached.

The split of the 714 NPA, and the beginning of a permissive dialing period, will take place at 2:00 AM Pacific Daylight Time (PDT) on Saturday, April 18, 1998. The permissive dialing period will end at 2:00 AM PDT on Saturday, October 17, 1998. During the permissive dialing period, either the 714 or 949 NPA code will be acceptable in a dialed number terminating in the new 949 NPA. ~~for all central office codes (NXXs) in service prior to the beginning of the permissive period. Please note: For NXXs that are opened in the 714 and 949 NPAs after the start of the permissive dialing period, the calling party must dial the appropriate NPA. Calls to these NXXs will be routed to an incorrect party or to intercept if the incorrect NPA is dialed.~~ After the permissive period, all calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept.

The attached map illustrates the 714 and 949 NPA configuration after the split. Another map shows street detail to assist in locating the boundary between the 714 and 949 NPAs. Also attached are listings of the assigned NXXs for the 714 and 949 NPAs as of February 1, 1997. The NXX information provided includes NPA, switch identification, rate center identification and rate center name, and is sorted two ways: numerically by NXX and alphabetically by rate center name. Since the attached NXX information may change over time, updated NXX information may be found either in the LERG or the NPA NXX Activity Guide (NNAG). Current information in the LERG and NNAG is available by license contract from Bellcore's Traffic Routing Administration (TRA) group, which can be contacted by dialing the TRA Hotline at 908-699-6700.

All international and domestic carriers are asked to ensure that the new 949 NPA has been activated throughout their networks prior to April 18, 1998. Test calls to verify routing to the new NPA can be made by dialing 949-777-0949, effective March 16, 1998. It is not expected the test number can be reached from outside the 714 NPA until shortly before the beginning of permissive dialing. Calls successfully completed to the test number will receive a recorded announcement. The test number will be disconnected January 1999.
